- On-site interviews, awarenessraising, commitment signature to Compliance statement and collection of documentation for the due diligence file.

#### **MONITORING**

Demonstrate that your integrity programme is complete and effective.

- Evaluate the proper design and roll-out of your integrity program.
   A point of focus for international financial institutions
- Conduct external reviews of the content and the implementation of your anti-corruption programme.
