## The Kingdom of Morocco Conformity Assessment Program

### Intervention at Destination



On March 24, 2021, the Kingdom of Morocco’s Ministry of Industry, Trade, Green and Digital Economy (MICEVN) signed an agreement with SGS Maroc SA to provide a conformity verification program for imported industrial products.

The program ensures imported products comply with the health and safety requirements in Moroccan standards and technical regulations. This protects consumers from unsafe and substandard goods, and local manufacturers, importers and distributors from unfair competition resulting from the importation of non-compliant industrial products.

PROCEDURE

Certificate of Conformity (CoC) Authentication (inspection at origin):

- SGS receives CoC details and documents via MICEVN interface. Information has been uploaded onto PORTNET by the importer or agent
- SGS informs the importer of the intervention level and submits a service invoice
- Depending on the verification result and document review, SGS either authenticates or rejects the CoC in the Ministry system

Intervention Process (inspection at destination):

- Through an interface with the MICEVN system SGS receives the documents and information uploaded to PORTNET by the importer or agent
- SGS informs the importer/agent of the intervention level, received from MICEVN or based on risk assessment, and raises a service invoice
- Intervention consists of documentary verification, inspection and/or inspection and sampling. If required, SGS will deliver samples to a Ministry approved local laboratory
- SGS liaison office in Morocco performs verification activities
- Depending on the verification result and document review, SGS either approves or rejects the cargo in the Ministry system.

APPROVED LABORATORIES

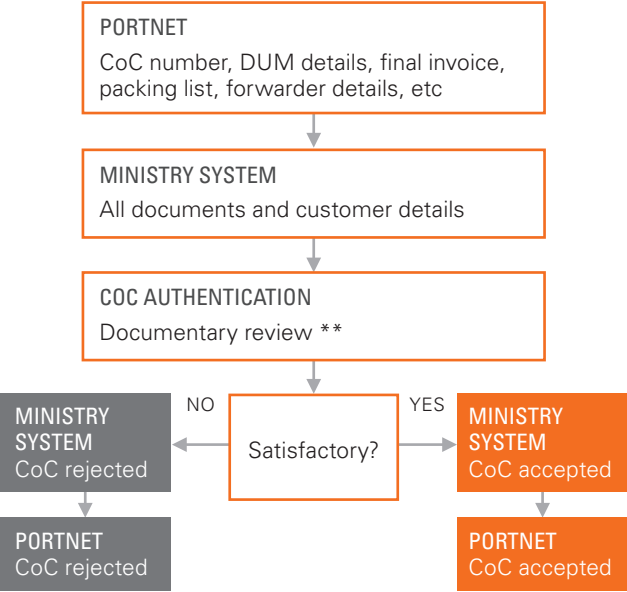
Approved laboratories are ISO/IEC 17025 accredited by an accreditation body which is a member of ILAC and other laboratories, as approved by MICEVN.

PLEASE NOTE

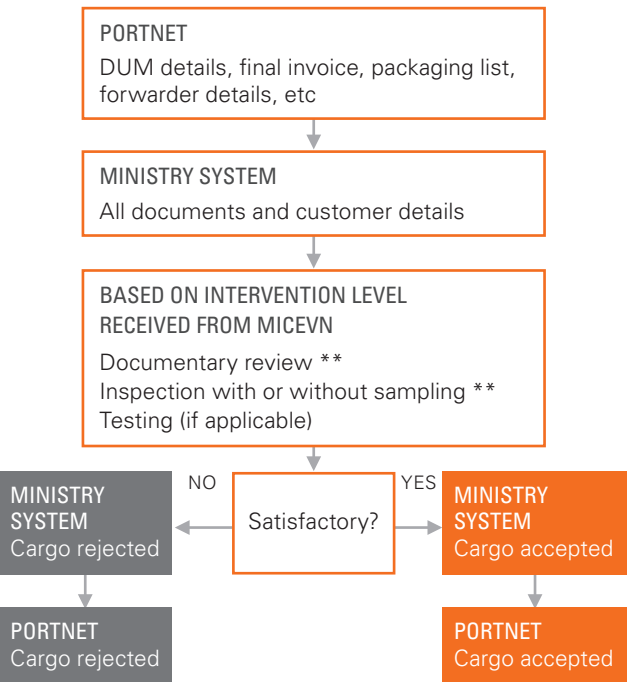
CoC is mandatory for goods that are inspected at origin when clearing customs

FEES FOR INTERVENTION AT DESTINATION

FEES PER TRANSACTION (MAD)

Fees cover document checks and, if applicable, physical inspection and/or sampling\*. They do not include laboratory testing, audits of manufacturing and technical industrial expertise, container sealing, and sampling of bulk products in shipment.

\* when sampling is required on several products, a supplement of 300 MAD/HT may additionally be invoiced for each new product. This begins with the second product and there is a recommended overall ceiling of 1,500 MAD.

\*\* Additional interventions can be performed at the importer’s expense.
